

Removing Notice of Lien from Clerk of Court Records

1. HAVE UCC-11 & UCC-3
2. GO WITH A WITNESS
3. FILE THE UCC-3
4. THE CLERK MAY GIVE RESISTANCE (i.e. "THEY ARE NOT SIGNED")
5. SAY: "THE IRS NOTICE OF LIEN WAS NOT PROPERLY SIGNED BY MAGISTRATE EITHER, YET THEY WERE FILED."
6. SHE MAY SAY UCC-3 WAS NOT NOTARIZED
7. SAY: NEITHER WAS THE NOTICE OF LIEN AND YOU FILED IT
8. TELL HER SHE WILL RECORD THE UCC-3. "I CAN AND YOU WILL".
9. SHE MAY SAY THE UCC IS STATE LAW AND IRS NOTICE IS A FEDERAL DOCUMENT
10. AGREE AND SAY THAT IS WHY THE STATE DOCUMENT CAN TERMINATE IT.
11. SHE MAY CLAIM FEDERAL LAW IS SUPERIOR TO STATE LAW
12. DISAGREE. I LIVE IN _____ STATE, UNDER STATE LAW AND DO NOT LIVE ON FEDERAL LAND.
13. STEPS FEDERAL GOVERNMENT MUST DO IN ORDER TO IMPOSE A FINANCIAL STATEMENT AGAINST SOMEONE IN THE _____ STATE:
14. a) MUST REGISTER IT WITH THE SECRETARY OF STATE AS A FOREIGN BODY OPERATING WITHIN THE STATE TO SECURE A LIEN.
b) AFTER SECURING THE ACTUAL LIEN, ONLY THEN CAN THEY BEGIN SENDING OUT NOTICES OF IT.
c) READ FROM THE NOTICE OF LIEN: "THEREFORE THERE IS A LIEN"
15. THEN ASK: "THEREFORE, THERE IS A LIEN AGAINST ME, RIGHT?"

16. SHE SHOULD SAY "RIGHT"
17. SAY: "O.K., SHOW IT TO ME AND I WILL LEAVE".
18. SHE MAY SAY: "WE DON'T HAVE IT HERE"
19. AGREE AND SAY: "YES, THAT'S RIGHT, IT'S AT THE SECRETARY OF STATES' OFFICE ISN'T IT??"
20. SHE WILL ANSWER "YES"
21. SHOW HER THE UCC-11 AND SAY: THIS PROVES THAT THERE ISN'T ONE THERE, RIGHT?
22. GIVE HER THE PHONE # TO THE SECRETARY OF STATES' OFFICE AND TELL HER THEY ARE EXPECTING HER CALL . . .
23. SHE WILL HAVE TO FILE THE UCC-3 AND RELEASE THE LIENS.
24. LATER: SEND HER A CERTIFIED LETTER, AS A FOLLOW-UP. THE LETTER PUTS HER ON NOTICE - - I EXPECT HER TO PROVIDE CERTIFIED DOCUMENTATION FROM THE SEC OF STATE SHOWING THAT A REAL LIEN IS PROPERLY ON FILE WITH THAT OFFICE BEFORE RECORDING ANY IRS NOTICES OF FEDERAL TAX LIEN BEARING MY NAME IN THE FUTURE.
25. THEN RECORD THE NOTICE IN THE COUNTY RECORDS TO GIVE IT A BOOK AND PAGE NUMBER.
26. POST IT IN THE COURTHOUSE ON THE PUBLIC BILLBOARD.
